Kamil heard this sentence many times since then. Then, someone was approaching to him and Kamil ran away again in panic.

What happened next can be described as an uncertain sequence of events. Kamil returned to the flat he left but no one was present. Everything calmed down as well as the Kamil's father for a short time. It was a preface to the events which Kamil could not imagine, at the moment.

He could not bear that Kamil excelled. Kamil was ball acrobat and the best player on the field. In his nine years, he won the bet scoring thirty goals in serie hitting the bar, then, a policeman approached the schoolmate Kamil beat and gave him money telling him to give

them to Kamil ensuring him that Kamil will be charged for theft, then the policeman told the schoolmate that he should call at "the hill" being a slang term for the local police department in the city Kamil lived. Kamil's schoolmate, then, wanted to give the money to Kamil but Kamil refused it, Kamil turned back to the schoolmate who put the money into Kamil's pocket. Just after Kamil's return home Kamil's babysitter stole the prize money from Kamil and reported him as thieve. Kamil stopped his football career after this single match due to his duties at high school where he had excellent marks and due to the fear of his health taking into account many fouls against him which could result in a severe injury. These fouls were arranged by the police in order to stop his career. Kamil knew these facts since other players discussed the plots against him so that he could hear it.

At high school, he had average study results, from the beginning. Then, Kamil studied hard and was getting better. He was one of the best students at the end. The behaviour of the people was changing as well. The colleagues ignored Kamil from the beginning. Then, the atmosphere was getting worse. Their behaviour cannot be described with any word. Kamil did know that he was accused of something. The worse was the fact that the classmates were at least twenty-years older than Kamil. Kamil did not defend himself since the colleague did not have enough strength to injure Kamil. Kamil let him to hang on his throat and waited until other colleagues separated the attacker from him. The colleague then got the nickname Arnold after the famous actor of action movies. This outraged him even more. Kamil then looked after himself and ignored the attacker which was better for Kamil.

Several physical attacks followed. One of them started when Kamil took a biscuit from the pack lying on the desk. The colleague which owned the pack then dashed on Kamil and threw Kamil down from the desk he was sitting on. Kamil was just smiling at the scene. The colleagues then attacked teachers. They wanted them to punish Kamil. The teachers did not understand the situation. They wanted them to punish Kamil themselves. The psychosis of the crowd supported by the perception that they did a good thing did not let the colleagues to

stop their actions against Kamil. They considered it to be a rightful punishment for Kamil. Kamil knew that any defence is useless, in this case. He was accused again. He did not know why. He did not know that his babysitter and biological mother was talking about him as a criminal though he was never officially accused nor convicted. It was a clear case for them. Kamil liked the babysitter and could not come to a thought that she would harm him. He did not feel guilty. He really could not since he never did anything bad, in his life. He considered these attacks as groundless. He finished the high school as top-rank student with excellent marks. He continued his studying at the university.

At the university, Kamil did excellent from the beginning. Kamil could not believe that studying could be so easy. His father was talking about him in a different way. He claimed that Kamil did not have the abilities for such school since it was considered to be one of the best mathematics and physics university. Kamil had the aptitude. He had the highes IQ in the tests for the new-coming students. It was the highest IQ ever found. Its value reached 200 points. His father did not want to admit it. Kamil felt the attitude but did not know anything specific. For Kamil, it was normal since the same behaviour he saw at the high school. The worse was the fact that Kamil could not go to the society since the crowd was claiming he is "mentally retarded" and "cheater". They assumed that Kamil had the tests before examination. They did not understand that Kamil was in absolute isolation implying that he could not get the tests from anyone. He could not go out. He did not live in the big city nor did he have any acquaintances or friends. The attitude was always against him. Kamil could not defend himself against slandering and attacks from other people. They did even worse things in spite of the fact that he had the highest score in the tests. They were embarrassed as a consequence of Kamil's skills. They did not cope with his pace nor did they understand his thoughts. They pointed to Kamil publicly claiming he is mentally retarded dissipating false rumours on him. To make things worse Kamil was marked with his extreme IQ at the beginning of his study. They gained absolute power disvaluing his results. Kamil could not defend himself. They passed the exams since the professors gave them the marks without examining them. On the contrary, Kamil was examined the more by them. The professors manipulated Kamil's marks and pointed to him at public lectures. They were convinced that they get the skills and positions of Kamil in spite of the fact that Kamil had no real power. They really got these positions since Kamil was mutilated and signed as inferior and really could not defend

himself. They themselves did not manage their duties expecting help from others even though they got the high positions. They had possibilities and knowledge Kamil could not even dream about. They sent a schoolmate to Kamil who cheated when he was playing desk games. They tried to defame Kamil and Kamil stroked back their attempts. He defeated his father in chess in his seven years. He defeated even chess computers. His schoolmates knew that but did not care about that. They were just angry because of Kamil claiming he is embarrassing himself. During holidays he won snooker game though he had never played snooker. He finished the game with final shot playing eight balls at the time. His competitors did not believe his skills. They accused Kamil of deceit. Then, they thought he is a professional player since they themselves were crooks. Then, the roommate was binding and narcotizing him, regularly, supported by general acceptance of the colleagues and professors since they could not bear his victories. They liked punishing and victimizing other people. Kamil almost died during these murder attempts. Kamil did not have any evidences on this. He could only surmise that it was a consequence of his extreme aptitudes. In reality, it was the consequence of mutilating initiated by his biological mother and family.
